## INTERNAL AUDIT COMMITTEE REFERRAL OF AUGUST 25, 2022 REGARDING POTENTIAL VIOLATION OF MDC ETHICS CODE BY COMMISSIONER TAYLOR

Commissioner Woulfe offered Commissioner Taylor the ability to make a statement. Commissioner Taylor asked for clarification of what he is being charged with and made a statement regarding his meetings with Dan Mara of Sandler & Mara PC.

District Counsel Christopher Stone read statements previously made by Commissioner Taylor from transcripts of the September 7<sup>th</sup> District Board Meeting and September 14<sup>th</sup> Ethics Advisory Board Meeting. Committee members and District Counsel Christopher Stone asked Commissioner Taylor questions regarding the meetings with Dan Mara.

Commissioners Avedisian made a statement regarding a phone call from Commissioner Taylor wherein Commissioner Taylor discussed meeting with Sandler & Mara about the 2021 and 2022 invoices.

Commissioner Mandyck made a statement regarding a phone call with Commissioner Avedesian wherein he described his prior phone call with Commissioner Taylor.

#### **RECESS**

At 5:27 PM, without objection, Chairman Woulfe called for a recess.

#### **RECONVENE**

At 5:42 PM, without objection, Chairman Woulfe reconvened the meeting of the Ethics Advisory Committee

At 5:53 PM, Chairman Woulfe requested an executive session to discuss written communication sent by District Counsel Christopher Stone.

On motion made by Commissioner Patel and duly seconded, the Ethics Advisory Board entered into executive session to discuss written communication sent by District Counsel Christopher Stone on September 19<sup>th</sup> to the members of the Ethics Advisory Board that is privileged by the attorney-client relationship within the meaning of §1-210(B)(10)

#### **RECONVENE**

At 6:28 PM, Chairman Woulfe requested to come out of executive session and on motion made by Commissioner Lewis and duly seconded, the Ethics Advisory Committee came out of executive session and reconvened. No formal action was taken.

Commissioner Patel made the following motion:

Be it resolved, the Ethics Advisory Board hereby finds and reports the following:

- 1) Commissioner Taylor admits that he met with Dan Mara of Sandler & Mara PC on two separate occasions to discuss disputed 2021 and 2022 legal invoices presented by Sandler & Mara, PC;
- 2) Without questioning the motives of Commissioner Taylor, the Ethics Advisory Board consider Commissioner Taylor's action to be technical violations of MDC Bylaw § B6d;
- 3) The Ethics Advisory Board hereby recommends that there be a finding of ethical violations as referenced above, but that the District Board take no discipline or censure against Commissioner Taylor, but rather that he be advised that any similar violations may lead to more adverse consequences; and
- 4) The Ethics Advisory Board further recommends no Commissioners meet with any individual or representative of any entity, constituent or otherwise, having an adverse claim or claims against the District. To the extent that there is any question as to whether any adverse claim exists, the matter should be referred to the Office of District Counsel.

On motion made by Commissioner Patel and duly seconded, the resolution was adopted by majority vote of those present. Commissioner Lewis voted no.

#### **COMMISSIONER COMMENTS AND QUESTIONS**
