

LINBROOK ROAD RESTORATION UPDATE OCTOBER 23, 2018

Based on the contractor's current projections, replacement of the failed section of liner has been scheduled for Thursday, October 25, 2018. As always, schedules are subject to change based on unforeseen construction related activities.

The attached flyer is being hand-delivered to affected properties and emailed to all whose email addresses have been shared with MDC.

Thursday, October 25, 2018

Replacement of the failed section of liner is scheduled to begin at approximately 3:00am. The installation of the new liner, including post lining inspection, is expected to take approximately 18 hours, at which time the new liner will be put into service.

Friday, October 26 – Saturday, October 27, 2018

Once all lining work is complete, crews will begin the removal of by-pass pumping equipment, ramps in front of driveways and related materials and begin clean-up and lawn restoration efforts, weather permitting. Due to the forecast, any work not completed on Saturday will be done Monday.

Access to driveways on Linbrook Road will be maintained throughout the duration of the remaining work. There may be a short period of time on Friday/Saturday while bypass pumps and ramps are being removed that individual driveway access may be temporarily interrupted.

Paving

Weather permitting, the Town of West Hartford's paving contractor, Galasso Materials, plans to begin road restoration following the completion of all MDC activities. The Town should be providing additional notification to the residents regarding the paving schedule. Street parking may be limited due to paving operations and truck traffic.

General Information

MDC staff continues to meet with each homeowner to discuss and finalize restoration work prior to proceeding. While MDC can work with other contractors, we prefer to have our contractor do the work so that all the costs are controlled through our contracts and we can assist with coordination necessary to complete the work. Additional information will be forthcoming regarding restoration.

Further updates will be provided as they become available, which is expected to be tomorrow afternoon.



SEWER LINING UPDATE

Linbrook Road Area

The Metropolitan District (MDC) and their contractor, Precision Trenchless, **will begin work to install the replacement liner on Thursday, October 25th at approximately 3:00 AM.**

The installation of the new liner, including post lining inspection, is expected to take approximately 18 hours to complete, after which time, the new liner will be put into service.

Once all lining work is complete, crews will begin the removal of all by-pass pumping equipment and related materials and begin clean-up and lawn restoration efforts on Friday and continue on Saturday, weather permitting. Due to the forecast, any work not completed on Saturday will be done Monday.

There may be a short period of time, while by-pass pumps and ramps are being removed, that individual driveway access may be temporarily interrupted. Otherwise, access to all driveways will be maintained.

The Town of West Hartford plans to begin road restoration following the completion of MDC's activities.

Schedules are subject to change based on unforeseen construction related activities. MDC staff and contractors must be properly identified and present ID upon request.
