
### Meeting Overview

- Attend District Board, BPW, Water Bureau, Committee Regular and Special Meetings, and FY' 23 Budget Meetings



### Individual Customer Matters

- 2021 Water Backup/Flooding Incident at Magnolia St./Albany Ave. properties in Hartford
- Leak adjustments
- Water pressure issues
- Street household flooding
- Property damage from CWP- and other infrastructure-related construction work
- Billing disputes and discrepancies
- Reservoir and recreational facility issues





### Payment Relief Assistance

- Advised customers about the potential availability of MDC's payment relief programs and those administered by MDC partners/affiliates, such as Operation Fuel (https://operationfuel.org/), and Community Renewal Team (https://www.crtct.org/), the latter of which is the Community Action Agency for MDC customers that is responsible for processing customer applications for assistance through the Low-Income Household Water Assistance Program (LIHWAP)
- Assisted customers in applying for LIHWAP and other programs in order to avoid shutoffs
- Leak adjustments and other credits
