PUBLIC COMMENTS RELATIVE TO AGENDA ITEMS

Judy Allen of West Hartford recently attended the press conference and public hearing on HB5888 related to the MDC. She believes the legislators explained the reasoning for the bill and that District Counsel Stone stated the changes were unnecessary. She

feels that a task force would be a long overdue review of the full MDC Charter to help update it.

Without objection, agenda item #3, "Election of Chairperson" was postponed until the end of the meeting.

2023 LEGISLATIVE UPDATE

Judy Allen of West Hartford believes that the MDC is transparent in some cases, but public perception is that it is not the case. She expressed that she wishes the disagreement by the MDC did not have to be contentious, and that people see things two different ways and all need to listen and understand each side. She also stated the MDC Charter is very outdated and needs to be updated.
