# PRESENTATION BY REA RESOURCE RECOVERY SYSTEMS RE: DANBURY BIODIESEL PROJECT

Al Barbarotta, Dan O'Neil, and Dr. Richard Parnas, representing REA Resource Recovery Systems, updated the Technology Committee on the progress made at their Danbury biodiesel facility and gave an overview of their Connecticut business plan.

#### **OPPORTUNITY FOR GENERAL PUBLIC COMMENTS**

Judy Allen, of West Hartford, stated that while the State of Connecticut, although looking at renewables and energy efficiency, she has not heard biodiesel talked about a whole lot. The legislation that required home heating oils to start blending in biodiesel was strongly opposed by the home heating companies because it did raise the costs. Also, the state of Connecticut has received a lot of money to help people convert to heat pump for energy needs. Lastly, when looking at the environmental justice issue, it is not only about the number of trucks, residents have a say in it all and their perception is as important as the science.
